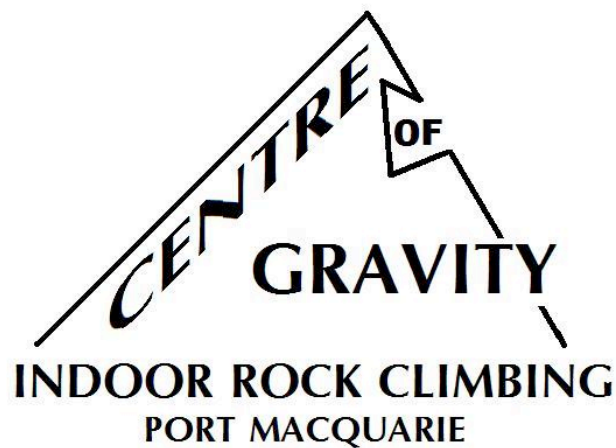

I HEREBY ACKNOWLEDGE & AGREE that I am familiar with the sport of indoor rock climbing & am fully aware & accept all the inherent risks of the proposed activity & acknowledge that the enjoyment & excitement of the activity is derived in part from the inherent risks, dangers & hazards, incurred by participation in an activity where risks are greater than accepted safety of life and home or work. Such risks including but not limited to personal injury, or death resulting from slips, trips, or falls while using the facilities or equipment, or failure of equipment, or injuries or death resulting from the fall of other persons or equipment who may come in contact with me or from any falls in which I or my equipment comes into contact with other persons. I understand that Sport Climbing Australia Inc and Centre of Gravity Climbing Gym (hereinafter jointly referred to as 'SCA/COG') take no responsibility for the condition of my personal climbing equipment including the type, age and condition of my harness. I KNOW THAT I CAN GET HURT USING THESE FACILITIES AND EQUIPMENT. I freely accept & fully assume all such risks & dangers & hazards & the possibility of personal injury, death, property damage or loss resulting therefrom. I choose to use the designated climbing facility, climbing facilities & equipment & agree as follows:-
